

Indy Hunger Network, Today & Looking towards Tomorrow

These days cuts to federal funding are a prime topic in news reports, and one of the first questions people ask me in conversation is: "has your work been affected by the cuts?" The answer is YES. With the passage of HR1, the "One Big Beautiful Bill Act", our work to ensure that everyone in the Greater Indianapolis areas has access to nutritious food got much harder.

For the past eight years, Indy Hunger Network has been a recipient of funds for Supplemental Nutrition Assistance Program Education or SNAP-Ed. SNAP-Ed has been administered by the USDA since 1992, providing funds to organizations that provide nutrition education and supports for people with low income. Despite documented success of SNAP-Ed funded programs across the country, SNAP-Ed funding was eliminated in HR1, and the program is now being phased out. No new funds will be allocated for SNAP-Ed work in the current fiscal year, which has left organizations like ours scrambling to find alternative sources of funding for several of our key programs, including Cooking Matters, our Healthy Nudges work with food pantries, and Community Compass. These programs helped over 55,000 Hoosiers in 2024 alone, and the loss of these resources will have a real impact on our community.

The other major impact of HR1 is the passage of substantial cuts to SNAP, which will be implemented over the next two years. Some of these changes are already starting, including the implementation of work requirements for veterans, young adults who have recently aged out of foster care, family caregivers, people experiencing homelessness, and people aged 55–64, who were previously exempt from work requirements. As more and more of these new SNAP policies and restrictions are rolled out, we will see a decline in the number of people who are able to access SNAP benefits, and that will put a strain on the already heavily stressed hunger relief system. Federal nutrition programs provide about 85% of the meals for people using food assistance in Marion County, and the food pantries and meal programs won't be able to fill the gap that will come from cuts to SNAP and other programs.

Now, more than ever, Indy Hunger Network could use your donation dollars to support our work. What Does the Government Shutdown Mean for Food Assistance Programs?

On October 1, 2025 the United States government officially ran out of allocated money. The fiscal year for the US government is from October through September. There have been shutdowns in the past, but not at the beginning of a fiscal year. The shutdown continues, as of this writing, and we will start seeing government programs not receive their funding soon. Starting with the Special Supplemental Nutrition Program for Women, Infants, and Children, or WIC. According to state sources, mothers and babies will continue to receive funds, at least in Indiana. Our understanding is the Supplemental Nutrition Assistance Program or SNAP is fully funded through the end of October. However, if the shutdown continues these payments might be reduced or cut in November. Again, according to our state source, this has never happened before because the state has supplemented payments until they were reimbursed after the shutdown ended.

On September 30, 2025 at midnight the SNAP-Ed program officially sundowned. The SNAP-Ed program provided Indy Hunger Network with almost half of its an annual budget for the last few years, which included about half of our staffing costs. Indy Hunger Network continues working tirelessly to replace these funds so we can continue nutrition education across Indianapolis and the surrounding counties.

Also beginning soon are the work requirement changes for SNAP benefits from the One Big Beautiful Bill Act. This is just the beginning of changes coming to not only the SNAP program, but also the Medicaid and Medicare programs.
